EXPORT STORAGE	
General cargo	0.30 PLN/kg/day – min. 90 PLN
Dangerous goods /DG/	0.95 PLN/kg/day – min. 150 PLN
Perishable goods /PER/ requiring controlled temperature*	0.80 PLN/kg/day – min. 200 PLN
Weapons, ammunition	1.20 PLN/kg/day – min. 500 PLN
Valuable shipments /VAL/	1.20 PLN/kg/day – min. 500 PLN

***The basis for calculating charges is the gross weight declared by the shipper on the transport documents.***

**CONDITIONS FOR APPLYING EXPORT STORAGE FEES:**

- 3 days of free storage for shipments, starting from the day the shipment is accepted into the warehouse.  
Storage fees according to the price list apply after 3 days, including weekends and holidays.

**EXCEPTIONS:**

- For shipments requiring special storage conditions, dangerous goods, valuables, weapons and ammunition- the day of warehouse acceptance is free of charge.
- For **perishable shipments (PER)**, requiring storage under controlled temperature conditions, charges are applied **from the first day the cold storage is activated until the shipment is collected.**

**CONDITIONS FOR ACCEPTING AIR EXPORT SHIPMENTS:**

- General cargo (with all required documentation)  
– 2.5 hours before aircraft departure or according to airline LAT
- Special cargo, dangerous goods, live animals (with all required documentation) – 3 hours before aircraft departure
- Acceptance of shipments below the specified time limits is treated as express handling – additional charge of 300 PLN

**IN CASE OF LARGE SHIPMENT WEIGHT / VOLUME  
EXPORT AND IMPORT HANDLING RATES ARE SUBJECT TO NEGOTIATION.**

**IF AN INDIVIDUAL CUSTOMER PRICING AGREEMENT IS APPLIED,  
SPECIAL CARGO HANDLING FEES FOLLOW THE GENERAL PRICE LIST.**

General cargo	0.30 PLN/kg/day – min. 90 PLN
Dangerous goods /DG/	0.95 PLN/kg/day – min. 150 PLN
Perishable goods /PER/ requiring controlled temperature*	0.80 PLN/kg/day – min. 200 PLN
Weapons, ammunition	1.20 PLN/kg/day – min. 500 PLN
Valuable shipments /VAL/	1.20 PLN/kg/day – min. 500 PLN

***The basis for calculating charges is the actual weight of the shipments.***

*\*Charges apply from the first day the cooling system is activated until the shipment is picked up.*



**CONDITIONS FOR APPLYING STORAGE FEES IN IMPORT**

- **3 days of free storage for non-EU shipments**  
*The date of warehouse acceptance is considered the first free day of storage; weekends and public holidays are excluded from storage charges.*
- **For EU shipments and shipments already cleared, the day of warehouse acceptance is free of storage charges.**  
*From the second day onward, storage fees apply according to the price list, including weekends and public holidays.*

**EXCEPTIONS:**

- *For shipments requiring special storage conditions, dangerous goods, valuables, weapons and ammunition, controlled temperature, etc.*  
**- the day of warehouse acceptance is free of charge**  
*(for customs shipments, the fee will be charged on the first working day)*
- ***In the case of customs shipments delivered on weekends or public holidays, the fee will be charged on the first working day***
- ***For perishable shipments (PER), requiring storage under controlled temperature conditions, charges are applied from the first day the cold storage is activated until the shipment is collected.***

#### CONDITIONS FOR STORAGE FEE CHARGES:

- The day the shipment is received at the warehouse is free of storage charges. From the second day onward, storage fees apply according to the price list, including weekends and public holidays..
